Master Forum European Studies - Prof. Dr. Hartwig Hummel, Dr. Jörg Waldmann

Wednesday 14:30h to 16:00h, weekly, building 23.02.U1.61
required, starting April 18, 2018

This weekly master forum supports students in writing their master theses. Topics include a) the development of research questions and designs, b) the presentation of papers relating to the thesis, c) comments on paper presentations by fellow students, d) group discussions on the papers and related issues. In addition, the master forum offers a regular platform for discussing issues and problems relevant to the course of study, including students' feedback and evaluation of the master program.

Certificate of attendance (Beteiligungsnachweis) will be issued for regular attendance and presentation of draft MA thesis.

Master Course - Business and European Integration - Prof. Dr. Hartwig Hummel

Tuesday 10:30h to 12:00h, weekly, building 23.31.U1.66
required, starting April 17, 2018

The course addresses the specific role of business benefiting from, and thus advancing, European integration. Topics include issues and actors relating to agricultural, manufacturing, and services industries and financial markets. We will discuss, among other topics, the free movement of goods, capital, services, and people; industrial policy and state subsidies; competition policy; supervision of financial markets; and corporate social responsibility. Classes will be based on assigned readings and presentations. Students are expected to already have a basic knowledge of political and economic institutions and decision-making processes in the European Union and of integration theories.

European Corporate and Competition Law - Ingrid C. Schneck, Prof. Dr. Christian Kersting

The course provides a basic overview concerning the core areas of the Common Market and its legal framework beyond the fundamental freedoms. These core areas are

1. European Corporate Law
2. Antitrust Law
3. Merger Control Law
4. State Aid Law
5. Public Procurement Law

Each area will be briefly presented with its legal cornerstones. The course is taught by two different lecturers specialized in the respective areas. Students do not need legal experience for this course.

Idea(l)s of Europe: The Historical Perspective - Dr. Oliver Kiechle

From Antiquity until the European Union of nowadays, Europe has always been an object of ideas and projections, even fantasies. In one part of the seminar we will discuss this different concepts of Europe in history with their respective ideas of the characteristics and borders of Europe. In a second part we will take a closer look on structural evolutions in European history. This will cover for example economical and cultural developments, but also changes of society with their associated ideologies.

Students are expected to prepare a presentation for one of the block days to have a basis for discussion.

The Europeanization of Political Parties - Dr. Jörg Waldmann

Tuesday 14:30h-16:00h, weekly, building 23.32.01.66
elective, starting April 10, 2018

Political parties are the centre-piece of democracy in Europe. In how far have they been affected by European integration? How can we understand the rise of populism in this regard? What role do parties play on the European level? The course attempts to provide an answer to these questions by, first, clarifying the role of political parties in theory and, second, move on to specific case studies. By examining the party systems in France, Germany, Britain, Spain, Italy, Poland, Denmark and the Netherlands common features and country-specific observations will be discussed.

The course is delivered through a combination of assigned readings, group presentations and panel discussions. Students will form 'member states groups' which acquire specific knowledge on their chosen country, thus serving as "country experts" in class and representing their country in panel discussions. Certificates of attendance require participation in group presentations.

The module is assessed by oral examinations. A detailed course outline, further information and relevant literature will be provided via course website.

The Evolution of a European Public Sphere - Dr. Jörg Waldmann

Thursday 10:30h-12:00h, weekly, building 23.32.01.66
elective, starting April, 12, 2018

There are many barriers to a real European public sphere. Should they be overcome, and if yes, how? In which sectors of society we are already living in a European public sphere? The course starts with elaborating on the theoretical implications of public spheres. Yet the main part of the seminar is devoted to case studies which touch upon very different aspects of society (culture, economy, sports, media, habits etc.).

The course is delivered through a combination of assigned readings, group research and presentations. With the help of groups, students will explore the Europeanization of the public sphere in a variety of fields.

Certificates of attendance require participation in group presentations or minor research projects. The module is assessed by oral examinations. A detailed course outline, further information and relevant literature will be provided via course website.
